1. Two completed application forms with a photo on each.
2. One completed "Report of Arrival" form with a photo and letter addressed to the Ambassador.
3. One completed "Work History" form.
4. One completed biography form pasted with one photo (if the applicant has not visited Myanmar during the last two (2) years.
5. **Prepaid Self-Addressed Envelope.** (FedEx/USPS-Express Mail/DHL/UPS/AirBorne) (Payment arranged through Credit Card is not accepted)
6. Passport of at least 6 months validity with available visa pages.
7. Payment of US\$30.00 per applicant for visa fee, payable to the Embassy of Myanmar in official check, company check or money order only. (Personal check is not accepted)

**VISA INFORMATION:**

- The Entry Visa for Social Visit is valid for a stay of 4 weeks and extendable at the Immigration Department in Yangon with US\$ 36 for 3 to 6 months.
- Visas are valid for **THREE MONTHS** from the date of issue, which cannot be renewed or refunded.
