

"BUSINESS VISA REQUIREMENT"

1. Two (2) completed application forms pasted with a photo on each
2. One (1) completed "Report of Arrival " form pasted with a photo
3. One (1) completed "Work History" form.
4. Business Letter of introduction from the Myanmar Company / U.S. Company on the company letterhead.
5. Prepaid Self-Addressed **FedEx's** Envelope. (**FedEx Standard Overnight Service**)
- **Payment arranged through Credit Card is not accepted**)
6. Passport of at least **6 months validity** with available visa pages.
7. Payment of **US\$30** (US\$ Thirty only) per applicant for visa fee, payable to the Embassy of the Union of Myanmar in official cheque or money order only.
(Personal cheque/cash is not accepted)

VISA INFORMATION

- The Business Visa is valid for a stay of 10 weeks.
- The Multiple Journey Entry Business Visa may be obtained for a fee of US\$150 at the discretion of the Embassy official.
- Visa is valid for (3) months from the date of issue, which cannot be renewed or refunded.

- 0930 (morning) - 1200 (noon) DROP-OFF
LUNCH TIME - **1200 - 1300**
- 1300 (noon) - 1700 (afternoon) PICK-UP

VISA PROCESSING TIME

Photography Guide (3 Photos for Business Visa)

- The photograph must have been taken within the last six months
- Identical photos must be submitted with the passport application
- The photograph should be in color and must be taken against a white or off-white background.
- Side or angled views are NOT accepted.
- The photograph for each visa applicant must be an unmounted, full face photo.
- Photo Size : The photo for each visa applicant submitted must measure:
2 inch X 2 inch or 50 mm x 50 mm
- Photo Appearance: The photograph must be a full-face view in which the visa applicant is facing the camera directly.
- Digital Photos: Digitally reproduced photographs must be reproduced without discernible pixels or dot patterns.

Photocopied photographs are NOT accepted.

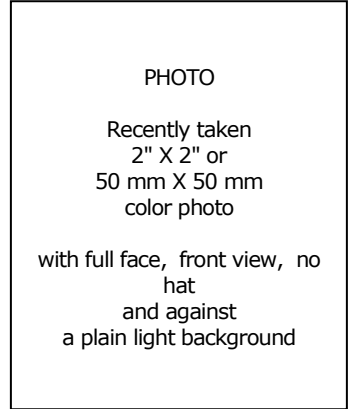
